- 3/ There should be electricity bill or receipt of electricity bill in the name of the customer.
- 4/ The customer will have to make advance payment as decided by the company according to the project, which will be based on the booking policy of the company.
- 5/ The approval period for this Fund Raise will be 3 months, and after approval it will take 20 days to install the project which should be acceptable to the customer.
- 6/ In this the customer has to deposit 1,50,000/- of the project as Down Payment with the company, if the work is not done on time then the customer can take 100% return of funds if he wants, but it cannot be refunded with in the stipulated time, and if the customer's Funds is approved
